# HELP KEEP THE BEACH CLEAN

# LEAVE NOTHING BUT FOOTPRINTS

Beach pollution is a huge problem that can be caused by a number of things.

People often leave their trash behind when visiting the beach. While most of the time this is unintentional, we must still try and remember to check for any trash before we leave.

Throughout the year most beaches have beach clean ups. Some of the most common types of debris that are collected include; plastic lids, food wrappers, plastic bottles, straws, plastic lids, bottle caps, and plastic bags. Over half of the marine debris that ends up in our ocean is from land!

It is important to pick up after yourself regardless if we are at the beach or not. When debris such as bottles or cigarette butts get tossed onto the ground, they go into storm drains and right into our waterways. Many types of litter take years to decompose such as plastic bags or aluminium cans.



## Consultation on New Entry Control Policy

## Responses sought by 18 July

The public consultation on a draft Policy on Entry Control to Ascension continues, with the deadline for responses set at Monday 18 July.

A robust system of entry control is a core function of government and is necessary for the good governance of the territory. As there is no automatic right to entry to, or right to remain in, Ascension it is important that decisions are made in line with established principles and procedures, and that these are applied openly, fairly and consistently.

By establishing a published policy that details these, including on what grounds permission to enter or remain may be refused, such decisions will be clearly understandable and open to public scrutiny.

In doing so, the new policy seeks to balance the UK government's policy that there is no right of residency in Ascension with the principles of an open, fair and proportionate approach to entry control.

## Island gathers together for 4th July Celebrations





Last Saturday, 9<sup>th</sup> July, saw the 4<sup>th</sup> of July Independence Day celebrations at the Volcano Club on the US base.

People of all nationalities came together for a great community event to help our American friends mark and celebrate Independence Day.

For Ascension, the weather was a bit chilly (25c maybe) with wind, some cloud and sporadic rain thrown in, but the indifferent weather did not stop everyone having a great time as they enjoyed classic American food, stalls and entertainment. The day was rounded off with the type of impressive firework display you would expect for 4<sup>th</sup> of July celebrations.

Holding the event on 9<sup>th</sup> July was down to how the Saturdays fell this year, but 9<sup>th</sup> July 1776 is actually an important date in the story of the Declaration of Independence.

Out of 13 colonies, 12 originally voted to approve the Declaration of Independence. At first, New York delegates did not officially give their support as their home assembly had not yet authorised them to vote in favour of independence. Though the vote for actual independence took place on 2<sup>nd</sup>July, it wasn't until the 4<sup>th of</sup> July 1776 that the Continental Congress formally adopted the Declaration of Independence, proclaiming those colonies were now free and independent states and no longer part of the British Empire.

It was on 9<sup>th</sup> July 1776 that the Declaration was read out for the first time in New York. After hearing it the soldiers and citizens present were motivated to pull down a nearby statute of King George III. This important piece of symbolism underlined the world changing events that were occurring. Six days later New York's delegates received permission from their assembly to agree to the Declaration of Independence.

A footnote to all this relevant to Ascension is that King George III continued his reign as British monarch until 1820, so when the British claimed Ascension in 1815 they named the main settlement after him – Georgetown.

The tradition of setting off fireworks on the 4<sup>th</sup> of July began in Philadelphia on July 4<sup>th</sup>, 1777, during the first organised celebration of Independence Day. Ships cannons fired a 13-gun salute in honour of the 13 colonies and set off fireworks. In years to come, various cities continued the traditions of celebrating Independence, holding picnics, parades, speeches and fireworks, though Boston was the first to designation July the 4<sup>th</sup> as an official holiday in 1783.

Although living thousands of miles away from their homeland, US Space Force and other US personnel on Ascension Island continue the strong tradition of celebrating Independence Day and 4<sup>th</sup> July has become a key date in Ascension's calendar. Seeing the community of Ascension join together last Saturday was another reminder of the close bond all nationalities on the island share.

## **Shark Tagging Project Begins**


## Tagging programme started to better understand shark movements

AIG is conscious of the difficulties and issues caused by the presence of sharks close to the island, and the work of the Conservation and Fisheries Directorate has been severely disrupted by their presence too. If their behaviour and movement patterns can be more fully understood, it might be possible to better predict where they go and when. To help identify and track shark movements, the Conservation and Fisheries Directorate are employing a variety of tagging methods including visual, satellite and acoustic tags.

#### Visual Tags

In the first stage of the tagging project the Conservation Marine Team are securing brightly coloured visual tags to the dorsal fins of sharks larger than 1m in fork length (the tip of its nose to the deepest part of the notch in its tail). Each of these tags displays a unique identification number.

The distinctive coloured tags represent six different zones around the island. AIG recognises that it will not be possible to record shark movements without the help of people living on the island. The public know the waters better than anyone, so AIG is asking that fishers, boaters, and visitors to the pier keep an eye out for tags on sharks. If you see a tag on a shark, please make a note of the tag colour and the number, along with where you saw it and at what time.



Once you've recorded this information, please get in touch with the Conservation and Fisheries Directorate by telephone on 66403 or by email through <a href="mailto:mpa@ascension.gov.ac">mpa@ascension.gov.ac</a>.

With everyone's help in recording when and where the tags are spotted, it will be possible to estimate the movements of sharks that remain close to the coast.

#### Satellite Tags

The next stage of the project will involve deploying 22 satellite tags that will send location and depth data to satellites when a tagged sharks surfaces. Deploying these will hopefully add to our knowledge of where sharks go when they are not visible inshore.

### **Acoustic Tags**

Finally, with the help of a UK government Darwin Plus funded project and visiting shark experts, next year acoustic tags will be implanted into a number of sharks. These tags will relay data to an array of acoustic receivers around the island, providing even more information on where the sharks are moving.

#### Protocol for tagging

Whilst we want to know where sharks are going, we do not want to do anything that could encourage additional sharks to come inshore. We also want to avoid attracting multiple sharks and getting them excited, as it would add unnecessary risk to those involved with tagging. Therefore, the shark tagging protocol involves only a small amount of bait on a hook. The bait is from a local species and is primarily tuna and grouper carcasses. There is absolutely no chumming involved during the tagging process.


The protocol involves catching sharks one at a time and pulling them alongside the boat so a tag can be secured to the dorsal fin. To catch the shark, a small chunk of bait is attached to a circle hook on the end of a 100m rope with two or three buoys along its length. The shark tires itself out by tugging on the buoys so that it is easier to pull the shark alongside the boat.

With a taut leader at the front and a tail rope at the back, the shark is held in position long enough to measure its length and record its gender, before the tag is attached to the dorsal fin. This method has been developed in consultation with shark experts and was previously used when tagging sharks at Ascension's seamounts.

#### Progress so far

Tagging efforts so far have seen tags deployed at several locations around the island. Of these, 19 yellow tagged sharks have been in the Boatswain Bird zone, 10 green tagged sharks in the Georgetown zone and three white tags in the Airhead zone. Several small sharks have been caught and measured but were too small for tagging.

In total, 28 female sharks have been caught ranging in size between 85cm to 270cm (fork length) and 13 male sharks have been caught with a size range of 80cm to 190cm (fork length). Only those greater than 1m in length were tagged. AIG will continue to update the community through notices and social media as more sharks are tagged and we



learn more about their movements around the island.

#### How you can help

While you are on or near the water please look out for the tags. If you spot one record the date, location, tag number and colour and then let us know. There will also be a data sheet in the shade hut at the pier for recording your observations. In the meantime please come into the Conservation Office or contact us through phone on 66403 or by email through <a href="mailto:mpa@ascension.gov.ac">mpa@ascension.gov.ac</a>.

We appreciate that everyone wants to know more about why shark numbers appear to fluctuate as they do and what the sharks are doing around the island, and with everyone's participation in this project we will be better able to track and understand this.

In Maths, the Reception children have been learning about halving and sharing. They especially enjoyed the sharing activity because they shared Iced Gems equally between themselves and then ate them!
















## **Emergency Defibrillators**

## Several out of service whilst awaiting new batteries

Members of the public will be aware that there are a number of defibrillators positioned in strategic sites around the island. The number of these has recently been increased from seven units to nine, with the two extra new units being positioned at the pier and at the Turtle Ponds BBQ area.

Unfortunately, due to a combination of technical and supply chain challenges, five of the nine sites are currently out of service due to issues with the batteries in the equipment.

The sites currently out of service are as follows:

- Comfortless cove
- Two Boats pool
- North East Bay beach hut
- Exiles Building
- Entrance to the old NASA Site

Sites that remain in service are:

- Pier-head
- Turtle Ponds
- Red Lion / Green Mountain
- English Bay beach BBQ area.

The Sea and Land Rescue Service is addressing this as a priority matter and expect to have it resolved following the arrival of the August FIRS.

As with any emergency, the public are advised to call for assistance by dialling 999 and requesting the service relevant to their emergency by pressing

- 1 for Police and Fire
- 2 for Hospital
- 3 for Sea and Land Rescue

## **UN Ocean Conference 2022**

#### Leaders meet to discuss future of the world's oceans

This week the world's second United Nations (UN) Ocean Conference, was held in Portugal to support the "Implementation of Sustainable Development Goal 14: Conserve and sustainably use the oceans, seas and marine resources for sustainable development."

Targets include reducing marine pollution, protecting marine and coastal ecosystems, minimising acidification, ending illegal and over-fishing, increasing investment in scientific knowledge and marine technology, and respecting international law that calls for the safe and sustainable use of the ocean and its resources. Although human activity has affected almost all marine ecosystems, Ascension's marine environment is fortunately relatively much less affected by human activity when compared to other areas of the world. Life here is more abundant and ecosystems are much healthier, supporting large biodiverse populations of fish and large predators as well as globally-important populations of breeding turtles and seabirds.

Ascension's Marine Protected Area (MPA) ensures that these ecosystems and their natural processes will remain healthy for the future, safeguarding the ocean against many of the human pressures seen elsewhere.

In September 2021 AIG published a five-year management plan for the MPA, detailing what actions will be taken to help further develop understanding of the MPA and ensure it retains some of the highest levels of protection seen anywhere in the world. The management plan links to many of the targets laid out in the UNs Sustainable Development Goal 14, which formed the basis of discussions at the UN Ocean Conference 2022. Some of these targets include reducing marine pollution, protecting marine and coastal ecosystems, ending illegal and over-fishing and increasing investment in scientific knowledge and sustainable use of the ocean and its resources.

Waters within our MPA are now legally protected from fishing beyond 12 nautical miles of the island, with large-scale commercial fishing banned within the entirety of the MPA. Mineral extraction, including deep-sea mining, is also prohibited. AIG, along with several partnering organisations and universities, continue to grow our scientific understanding of Ascension's marine environment.

Work is underway to develop an Inshore Fisheries Policy, and funding has been awarded to appoint a Marine Plastics Coordinator to analyse single-use plastics usage in Ascension and assess what can be done to help reduce this.

Some of our current research projects focus on zooplankton, plastic pollution, green turtle monitoring and shark behaviour. AIG is also working to support the sustainable development of social and economic activities within the MPA. We want the island community to realise the health, welfare and economic benefits of the MPA in ways that don't compromise the prosperity and enjoyment of future generations.

## **Two Boats Perimeter Fence Repairs**

### Restorative work to be undertaken in July

In response to concerns raised by members of the public, the Two Boats perimeter fence is to be repaired during July, along with replacement of the Two Boats cattle grids.

The fence, which AIG is not the responsible for, was installed by a third party many years ago and recently members of the public and Councillors have raised concerns about its state of repair and the fact that it no longer prevents feral sheep from entering Two Boats.

A subsequent inspection of the entire fence perimeter has showed that although the vast majority of fence remains effective, some areas are in need of repair.

Although AIG is not the responsible for maintaining the fence, as the works identified are not thought to be substantial, AIG will carry out repairs over the course of this month. However, it should not be expected that AIG will undertake further work on the fence in the future and AIG is not assuming liability for future maintenance of the fence. Alongside this, work will also take place to replace the cattle grids around Two Boats. As work on the grids will mean adjacent sections of fencing will be disrupted, it is expected both sets of works will e completed by the end of the month.

It has also been queried whether sheep currently within Two Boats can be removed. Regrettably this is not something AIG can undertake. The reason for this is that no AIG employee has appropriate training to handle this livestock due to the fact that AIG has no liability to manage feral animals such as sheep.

However, should the sheep not leave the area after the fence repairs are complete, AIG will continue to work with Councillors and those living in Two Boats to try and find a way forward on this subject.

A further public notice will be issued closer to the time when the cattle grid replacement programme is due to start.

# **Preparing for COVID-19**

### Recognising the symptoms of COVID-19 infection

From Sunday 31 July, Ascension's COVID-19 protocols and procedures will undergo significant change. Arrivals will no longer be required to observe quarantine following their arrival, or be required to take pre-departure or arrival testing.

As a result, it is expected that COVID-19 will become established in the community and the island will transition to a state of living with COVID-19, as most of the rest of the world has now done.

It is important that members of the public therefore familiarise themselves with what the symptoms of COVID-19 look like.

Symptoms can take many forms and different people will experience COVID-19 infection in different ways. When infected some people may develop one or more of the following symptoms, or may even develop none:

- a new continuous cough
- a high temperature
- a loss of, or change in, your normal sense of taste or smell
- a sore throat
- diarrhoea or vomiting
- muscle aches and pains

It is important that people remain mindful of their own health and if they think they have symptoms consistent with those listed above, following the process for arranging a test.

- Telephone Georgetown Hospital on 66252, or if you live on one of the military bases the relevant base medical clinic
- Arrange a time to attend the Hospital, or one of the military base medical clinics, to be tested
- Following your test you should go home, avoid contact with other people and self-isolate whilst you wait your results
- If you test positive, self-isolate in line with the self-isolation guidance and contact your employer to let them know

## **COVID-19 Response Level Reduced to Level 1 AMBER**

Further tests confirm previously positive individual in quarantine now negative

#### **Key messages**

- One recent arrival, who was in compulsory isolation when testing indicated a positive result for COVID-19, has subsequently tested negative for COVID-19.
- Results from repeated testing conducted over the weekend indicate the individual is negative for COVID-19 and are therefore no longer infectious.
- The Response Level has been reduced to Level 1 AMBER.

On Saturday 25 June, an individual observing compulsory isolation measures returned a positive COIVD-19 test result during routine testing of persons under quarantine.

In line with Ascension's COVID-19 policies and procedures, the individual was monitored by medical staff and subject to additional testing to confirm the level of their infection.

Further testing conducted on the individual in the last few days has returned multiple negative results and as such they are no longer deemed to be infectious or a risk to others. They have therefore had their period of compulsory isolation ended and the Ascension COVID-19 Response Level has been reduced to Level 1 AMBER.

As ever, anyone who develops a new persistent dry cough, a fever or experiences unexpected shortness of breath should go home, self-isolate and telephone Georgetown Hospital on 66252 for further advice.

#### **Background**

The individual in question had arrived at Ascension on Thursday 23 June on a flight from the USA. They had previously returned negative COVID-19 test results on arrival at the island. As with all persons under group quarantine, they were subject to testing during their isolation period.

The result of this test was positive. The individual currently has mild symptoms and is otherwise well.

As they were observing compulsory isolation in a bubble, the other persons in that bubble will now also remain under quarantine and observation by medical staff.

Tests conducted earlier in the week on the positive individual returned successive negative results. Given these negative results the Senior Medical Officer is satisfied that there is no risk to the public from the previously positive individual, and they were granted permission to end their period of isolation on Monday 04 July.

This is a scenario that AIG had planned and prepared for. Robust measures for effectively managing arrivals to Ascension have been in place throughout the COVID-19 pandemic. These protocols have been developed in liaison with experts from the UK Health Security Agency (UKHSA) and are designed to ensure that any person arriving at the island is kept separate from the general public until the Senior Medical Officer can be assured that they do not pose a risk of introducing COVID-19 into the community.

Even though the individual that tested positive had not had any contact with the wider public, and therefore COVID-19 was contained, the level of risk to Ascension from COVID-19 had increased and as a result the response level was raised. Following the negative test result and confirmation that the threat from COVID-19 had reduced, the response level was returned to Level 1 AMBER.

# Marine Conservation Scientist – Shark Project

#### About the role

Do you have a passion for Marine Conservation? The Ascension Island Government Conservation & Fisheries Directorate (AIGCFD) is looking to recruit a highly-motivated marine scientist to lead the delivery of a Darwin Plus-funded project which, working closely with an international team of researchers from the University of Exeter, University of Windsor, Zoological Society of London and University of Plymouth, will investigate and address the biological and social drivers of human-shark conflict on Ascension Island. The remote UK Overseas Territory of Ascension Island is surrounded by one of the world's largest highly-protected marine protected areas. Established in 2019, the MPA seeks to conserve Ascension's globally important marine biodiversity while contributing to the socioeconomic wellbeing of the island's small human population. In recent years, the presence of large Galapagos sharks in shallow, coastal waters has led to conflict with local ocean users. If not appropriately managed, such conflicts have the potential to significantly undermine the MPA's conservation and societal benefits.

#### What you'll do

Working closely with the above stakeholders, the post holder will be based in AIGCFD's marine team for two years from October 2022 – September 2024. The successful applicant will be responsible for delivering a programme of applied shark research and communicating findings to local and international stakeholders through presentations, reports and peer-reviewed publications.

#### What you'll bring

The ideal candidate will have a PhD or equivalent professional experience in marine vertebrate ecology/conservation, with a proven track record of leading, managing and disseminating a programme of scientific research. Prior experience of animal biotelemetry (acoustic telemetry) and of working with elasmobranchs in a field setting is highly desirable, although full training will be provided at the start of the project. You will be culturally aware, able to work independently and as part of a small team, have strong interpersonal skills, and will be happy living and working in small/remote island community (see job description for full person specification). Ascension Island is a challenging environment to live and work in, so you will need to be resilient and adaptable in order to thrive. The post would be ideally suited to recent PhD graduates looking to take the next step in their career through a rare opportunity to work with a consortium of internationally-renowned research institutions while contributing to the management of one of the world's largest marine protected areas.







# RECOGNISING FINANCIAL **SCAMS**

As St Helena becomes more exposed to the world, those on-island can become more visual to scammers. Bank of St Helena Ltd would like to help you spot scammers in advance to protect you and your money.

#### It might be a scam if:

- It seems too good to be true for example, a holiday that's much cheaper than you'd expect.
