# **Ascension Island Council – General Election 20 October 2022**

## **Nomination of candidates**

A General Election will be held in Ascension Island on Thursday 20 October 2022 to appoint a new Island Council. In order to vote in the election individuals must be listed on the current Register of Electors.

### **Qualification for elected membership**

In order to qualify for election as a Councillor an individual must:

- be aged 21 years old or over and be eligible to vote in the election for which they are nominated; and
- be a British Overseas Territories citizen, British Overseas citizen or British citizen who is registered in the current Register of Electors that has been compiled and published in accordance with the Elections Regulations 2008. Copies of the register are available on the notice boards at the AIG building, NAAFI Store and at Two Boats Club, at the USAF Base Library, or within the Administrator's Office.

### **Disqualification for elected membership**

The Island Government (Ascension) Ordinance 2008 sets out certain disqualifying criteria for elected membership and refers to persons:

- who have been convicted of an election offence; or
- who have within five years immediately preceding the date of the election, served a sentence of imprisonment of 12 months or more; or
- who hold, or are acting in, any public office designated by the Governor (a list of such public offices can be obtained from the Administrator's Office).

Individuals are encouraged to consider whether they would like to stand as a Councillor or, if not, who they would like to see as their representative on the Island Council.

### **Nominations of candidates**

Nomination forms are available from the Assistant Returning Officer (Siobhan Stewart) in the Administrator's Office in Georgetown as well as the Returning Officer (Diane Baum) in the Conservation Building.

When completing a nomination form, individuals should ensure that:

- The names of the candidate, proposer and seconder are on the Register of Electors; and
- The signatures of the proposer and seconder have been witnessed by a Justice of the Peace (Jolene Sim, Martijn Smeets, Paul Bennett and Lisa Bailey) or the Returning Officer Diane Baum or the Assistant Returning Officer Siobhan Stewart. The candidate's signature may be witnessed by someone of their choice.

Nominations will be accepted from 23 September 2022, with the deadline for final submission being 16:30 on Wednesday 05 October 2022.

Lay Advocates are supported by the Public Solicitor's Office and receive a monthly payment of £60, Residential Silver Broadband internet allowance, additional fees for each court and police station appearance and travelling and other expenses.

## **THE APPOINTMENT OF LAY ADVOCATES**

### **Introduction**

Lay Advocates have an important position within the St Helena and Ascension Island legal systems and are vital in ensuring that individuals and companies receive legal assistance. They are not only important but the position carries a great deal of responsibility and a large element of public service.

The role of the Lay Advocate is to protect and promote your client's rights.

The power to appoint Lay Advocates is specially set out in the Lay Advocates Ordinance ('The Act') (section 3), "after consultation with the Justices Meeting". The matters to be considered in the Justices Meeting are set out in section 16 of The Act.

This document has been written to identify the proper objectives and criteria to be applied when appointments are being made and to set out the process that will be followed in considering any appointment as a Lay Advocate.

### **The Objectives and Criteria for Appointment**

The following matters shall be considered in connection with the appointment of Lay Advocates.

- a) That the process of appointment should be fair and, as far as appropriate, transparent.
- b) That everything possible is done to ensure that Lay Advocates of the right quality are appointed. The qualities looked for would include, in addition to the obvious attributes of honesty and integrity, the ability: -
  - i. To maintain client confidentiality. This is essential especially within a very small community where information travels very rapidly. By the nature of the role information will be available often on matters of huge public interest where even mentioning involvement can have an impact;
  - ii. To represent their clients properly and fearlessly including court presentation; and
  - iii. To understand the professional and legal issues that are involved in representing individuals. To understand the need to facilitate settlement of disputes and avoid hearings.
  - iv. To understand the importance of avoiding acting in any situation which could (or might to an outsider appear to) give rise to a conflict of interest. To appreciate that there are many areas of law which are complex and not to hesitate to consult with the Public Solicitor. There is always a difficulty in "knowing what you don't know" which applies to all legal levels (including the Public solicitor!).
- c) That the Lay Advocates should have such a reputation and position in the society of St Helena that it is likely that potential clients will have confidence and trust in them as a person who will represent them, protect their interests and maintain confidentiality.

### **The relationship with the Public Solicitor**

The relationship with the Public Solicitor is an unusual one.

Lay Advocates are not employed by the Public Solicitor Office.

The Public Solicitor has the power of appointment and dismissal although this latter requires the consent of the Governor<sup>1</sup>. The Lay Advocates can and will find themselves involved in legal matters where the Public Solicitor appears for the other party although it should be noted that, as a matter of policy, after consultation with the Governor, Attorney General and Chief Justice, the present holder of the post of Public Solicitor endeavours where possible to avoid any matter which is likely to involve court process and where the “other side” would then have to turn for assistance to Lay Advocates. The reason for this is firstly to maintain the Public Solicitor’s role of assisting, supporting and training Lay Advocates. The Public Solicitor clearly can play a far more active role providing assistance and support to the Lay Advocate (and if necessary to Lay Advocates on both sides) and to ensure that as far as possible there is “equality of arms” between residents of St Helena who don’t have any possibility of obtaining legal advice for a qualified lawyer.

<sup>1</sup>The Appropriate section reads: “The Public Solicitor, with the approval of the Governor, may remove any person from the office of Lay Advocate.”

The Public Solicitor does have a supervisory role in respect of Lay Advocates:

*6. Every Lay Advocate shall comply with any lawful guidance or instructions issued from time to time by the Public Solicitor as to the performance of the duties and the exercise of the rights of a Lay Advocate; and with any request (not being a request for the disclosure of confidential information) for information similarly issued. (Amended by Ord. 15 of 1997).*

The way in which this works in practice is that the Public Solicitor makes her/himself available as a first call of his time to any Lay Advocate who wants to seek advice or assistance. S/he also conducts regular training, which all Lay Advocates are expected to attend. The present holder has never had any reason to make any direction and the relationship between the Public Solicitor and the Lay Advocates is one of mutual respect where any potential problems are discussed and resolved.

### **The Lay Advocates Statutory Immunity**

Lay Advocates have protection from being sued by clients. This is an important and very wide protection.

*(3) No Lay Advocate shall be liable to be sued in any civil court for any act done by him in exercise of his powers, rights or duties under this Ordinance, provided that he did the act complained of in good faith in a manner in all respects consistent with the provisions of this Ordinance.*

This protection is central to enabling Lay Advocates to play their role, which would normally require legally qualified personnel.

### **Rights and Powers of Lay Advocates**

These are set out in the Ordinance section 6 and in brief they include: -

- a) Rights of audience at every court in St Helena including the Supreme court;
- b) To be supported and given assistance in understanding the law by the Public Solicitor’s Office;
- c) To see any person in custody who has requested to see them.

### **The Obligation of the Lay Advocate**

These are again spelt out in the Ordinance but can be summarised as follows: -

- a) He or she must not charge fees. The Lay Advocates receive a monthly payment as set out in a separate document.
- b) Not be involved in any matter in which he or she has a personal interest, which might conflict with the interests of the client.
- c) Take reasonable care to ensure that the advice and assistance is based on an understanding of the relevant law.
- d) Keep a record of clients and of actions taken or advice given in acting for the client.
- e) Maintain strict confidentiality.

There is an additional obligation which underpins the others and that is to behave in a way consistent with an important role within the legal system of St Helena and not to take action likely to bring the role into disrepute.

### **Conclusion**

The Lay Advocate role is an important and challenging one. The Lay Advocate is unique to St Helena and Ascension Island and the fact that it works owes much to the ability and integrity of office holders. Its existence has depended on the abilities of a very few people and its future is dependent on individuals of the calibre being prepared to fill this demanding role. It is worth adding here that all the existing and previous Lay Advocates have made it clear that it is a role which they find hugely enjoyable, fascinating and worthwhile.





## **Weekly COVID-19 Statistics**

### **Monitoring of community spread continues**

On Monday 08 August, Ascension recorded its first case of COVID-19 within the community. Since then, further cases of COVID-19 have been recorded and authorities are monitoring the spread of virus.

In order to ensure the public has a clear picture of infection rates within the territory, weekly infection statistics are being published during the period of transitioning to 'living with COVID-19'.

As of Wednesday 28 September, the total number of positive results from tests conducted by, or registered with, a healthcare worker at one of the three testing sites is as follows:

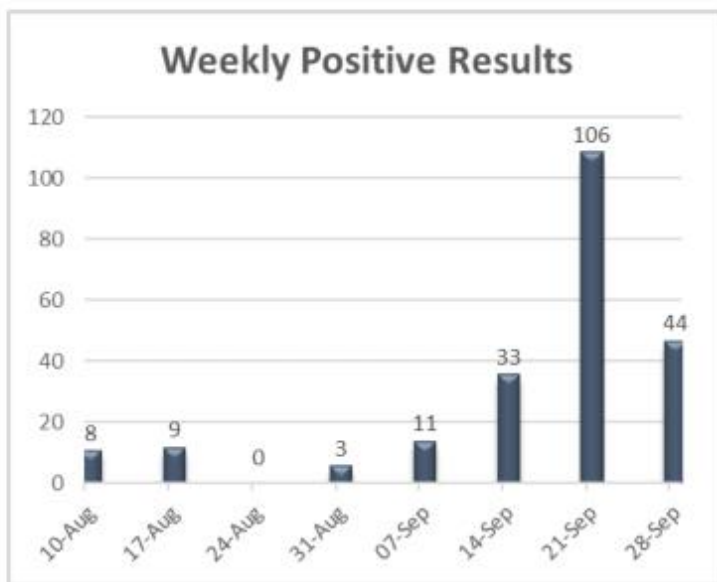
These figures are based on results of tests conducted at each of these sites. However, the test site may not necessarily reflect the primary accommodation location of the person that tested positive.

Between Thursday 22 September and Wednesday 28 September the following number of daily positive results from tests conducted by, or registered with, a healthcare worker was recorded:

As of Wednesday 28 September, there has been a total of one critically ill patient, who had tested positive for COVID-19, admitted to Georgetown Hospital. They have since been medically evacuated for further treatment off island.

The number of confirmed weekly positive results is as follows:



All members of the public are encouraged to monitor their own health for signs of possible infection. If you believe you have symptoms consistent with possible COVID-19 infection you should arrange to take a test at your relevant medical facility and follow the guidance in place. Guidance can be found online at [www.ascension.gov.ac/public-document/living-with-covid-19](http://www.ascension.gov.ac/public-document/living-with-covid-19) and is available through your employer, local medical clinic and Georgetown Hospital.

If you test positive, you should isolate for five days. After this time, you should end your isolation once you feel well. A test is not required to end isolation.

Authorities are monitoring the ongoing spread of the virus and the current guidance will remain in effect until they are satisfied that the daily positive incidence rate indicates that the peak of the spread has been passed.

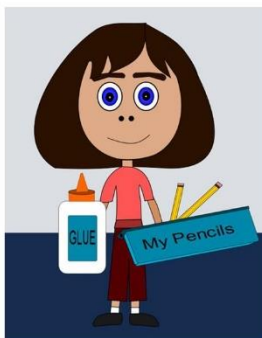

**Hello and welcome from Year 8.** The students have been working very hard in all their subjects and would like to tell you about some of things they have been up to.



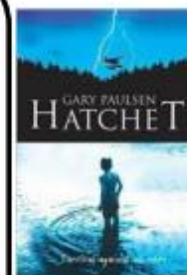
In English we've been learning about Sherlock Holmes. In the last week we've been talking about women in Victorian times and how they were treated very poorly compared to men who could vote, go to work and much more. Women couldn't vote or go to work which meant that they had to stay home and do all the work around the house. And if they had any daughters or sons, usually the sons would go and work and the daughters would stay home and help their mum around the house.



In history we have been doing The Industrial Revolution. So far we have focused on Disease. Back then spread of disease was more diverse as there weren't cures and they didn't realise how it spread. Cholera was one of the most popular infections caused by exposure to sewage and contaminated water. This could kill you in a matter of hours due to loss of fluid: vomiting and yellow diarrhea.



In tutor, on a Tuesday, we do D.E.A.R, (drop everything and read). We've recently been reading The Hatchet. It is about a boy, Brian, who has divorced parents. When he goes on a bush plane to visit his dad, who lives in Canada, the pilot gets a heart attack and becomes unconscious leaving Brian to attempt to fly an airplane, above a forest, in the middle of a Canadian forest. He then crashes and has to survive in the wild. Reading is important as it helps to build our vocabulary which will help us in later life as an adult.



In art we have been learning how to draw realistic drawings by using basic shapes for example we drew a picture of a bird using shapes such as triangles, circles and ovals. We even used a grid to help us to draw a horse it was complicated at first. We are all starting to get the hang of it.



In science we have been learning about nutrients and diets. We have been seeing what makes a balanced diet and how you can stay healthy. We learned all the nutrients and how much we need in a day.
